

# SEVENTH RACE Horseshoe Indianapolis JULY 5, 2025

1 MILE. ( Turf ) ( 1.33 ) SNACK H. Purse \$100,000 ( includes \$65,000 ITDF – Indiana TB Development Fund ) FOR REGISTERED INDIANA BREDS, THREE YEARS OLD. No nomination fee, \$150 to pass the entry box, and an additional \$100 to start with \$100,000 Guaranteed. Supplementary nominations may be made by the usual time of closing of entries for a fee of \$625 which includes entry and starting fees. After paying 1% to all owners of horses finishing sixth through last, purse to be divided 60% to the winner, 20% to second, 11% to third, 6% to fourth, and 3% to fifth. Trophy to the winning owner. This race will be limited to 12 starters. If more than 12 horses pass the entry box preference will be given to those with the highest weights. Second preference will be lifetime earnings. Entry fee only will be refunded if failure to draw into the race. If this race is taken off the turf, it will be run at a mile and seventy yards on the main track. Closed on Friday, June 20, 2025, with 36 Nominations. If this race is taken off the turf, it will be run at 1 mile and 70 yards on the main track.

CHICORY BLAZE stalked the pace in the three path, rallied near the half-mile pole, dueled through the stretch and lasted while kept to task. MACKADOO stalked the pace in the two path, rallied in the four path on the far turn, dueled and was outfinished. RAPID JUSTICE was squeezed back at the start, raced well back and bid late for the show spot. POLAR DRIFT stalked the pace inside but had no late bid. BOURBON CURIOSITY stalked the pace in the two path but couldn't close. BREEZY JUSTICE raced well back, bid in the five path near the three-eighths pole and improved position late. SPECIAL CREED broke outward, dueled outside of a rival, bid at the three-eighths pole and gave way in the stretch. GIN AND WHISKEY stalked the pace in the three path and faded in the stretch. NINETEENFOURTYFIVE passed tired foes. READY TO SEIZE raced well back and passed tired foes. AIR CHARGER saved ground to no avail. CONFERENCE CALLING dueled inside before giving way near the three-eighths pole.
