1 MILE 70 YARDS. (1.374) GOVERNOR'S H. Purse \$250,000 (includes \$75,000 ITDF – Indiana TB Development Fund) FOR REGISTERED INDIANA BRED THREE YEAR OLDS. No nomination fee, \$200 to pass the entry box and an additional \$200 to start. Supplementary nominations may be made by the usual time of closing of entries for a fee of \$1,000 which includes entry and starting fees with \$250,000 Guaranteed. After paying 1% to all owners of horses finishing sixth through last, purse to be divided 60% to the winner, 20% to second, 11% to third, 6% to fourth and 3% to fifth. Trophy to the winning owner. This race will be limited to 12 starters. If more than 12 horses pass the entry box preference will be given to those with the highest weights. Second preference will be highest lifetime earnings. Closed on Wednesday, July 9, 2025, with 36 Nominations.

SIR BAHJY saved ground, angled to the four path near the quarter pole, closed but was no match for the winner. RAPID JUSTICE saved ground, angled to the five path at the three-eighths pole and closed strongly. TERMINALLY HANDSOM was unrushed early and had a belated rally outside. MACKADOO rallied inside near the three-eighths pole and faltered late. DR. ALEX IS IN was clear early but couldn't last. GIN AND WHISKEY saved ground but had no late bid. MONDAVILA stalked the pace in the three path and faded near the quarter pole. SLAM DUNK JUSTICE saved ground and faded on the far turn. SPECIAL CREED raced in the four path and faded in the stretch. FACE THE FUTURE saved ground and gave way on the far turn. TRUSTED IMAGE was through early between rivals.
