RUSTY MY BROTHER set a fast pace on a clear lead for five-eighths, was no match for the winner when challenged nearing the quarter pole and finished willingly to hold the place. JEANNE MARIE tracked the pace from mid-pack well off the leader, was put to an early drive leaving the three-eighths pole and made a steady advance with a grinding rally. OMIKAMI unhurried in the early going to be the trailer, continued to be at the rear of the main body of the field turning for home, angled seven wide in the lane and rallied mildly with a belated bid. CORINNA was reserved in hand into the first turn to be near the back of the pack and went evenly failing to mount a bid. GENEVIEVE'S Z VA chased the quick pace down the backside and came up empty on the turn. SUSANOO was through early.
