OEU VRE tracked the early leader sitting inside of JERSEY PEARL up the backstretch, came under a ride past the midway point around the turn, cut the corner entering the upper stretch, ran on down the lane along the inside and secure da share. BOURBONBREEZE raced off the early pace, coaxed two wide into the upper stretch and made up some ground. CHARLEE MAE dropped to last after the opening quarter, came two wide into the lane and had no response.
