READY FOR SHIRL was allowed to settle between runners galloping along near the rear in the early stages, be gan to reach for more ground when urged three wideat the five sixteenths pole, angled out gathering momentum in the five path between horses turning for home and with a busy ride had relentless pursuit on the frontrunner in the final furlong to get up for the win in the shadow of the wire. GIMME A NOTHER (SAF) had the front setting a snail's pace along the backside, continued up top dictating an even tempo hounded outside around the bend, got a breather in the third split still quite in control at the top of the stretch, dug intenaciously holding on down the lane but just could not fend offthe late charge by the winner in the final few jumps. **VENENCIA** (FR) settled at the rear on the outside with the field tightly grouped along the back straight, kept pace but was going three wide on the outside to do so through the turn, was fanned out widest in the six path starting to lengthen her stride straightening out for home, kept on gaining steadily outside down the lane, was closing insmartly in the final furlong, switched back to the incorrect lead with a sixteenth mile from the prize, nevertheless still kept coming on to the end but just could not get to the winner in time still showing a very solid effort in deep stretch. SCARLET POPPY (IRE) tracked three deep outside watching the lead pair down the back straight, kept pace remaining three wide around the turn with the field bunched up, was in the conversation at the quarter pole three wide straightening out for home, battled on until the sixteenth pole but evened out in deep stretch between runners for a minor role in the end. CREVALLED'ORO settled on the fence in the middle of the pack, drafted just behind the leader saving all the ground on the fence waiting for the cue to go, continued the rail trip having clear run at the top of the stretch but failed to fire inside horses in the last eighth of a mile. LIFE'S AN AUDIBLE was content to sit of the outside flank of the pacesetter along the back straight, continued to have a shadowing role outside throughout the turn keeping a close eye on the leader, was nudged for more three eighths out making no gain on the frontrunner and in the two path between rivals had little to offer in the late stretch run yielding at the furlong pole.
