INDY BAY laid up close in the two path, was coaxed along in the three path passing the quarter, bid while floating out to the seven path at the top of the lane, veered into the five path and bumped an inner foe while taking command going by the sixteenth pole, and inched clear. VODKA WITH A TWIST prompted the pace in the three path, bid in the two path around the far turn, headed an inner foe while floating out to the five path in upper stretch, ran on but got bumped and put in tight by an outer foe while being overtaken by that one passing the sixteenth pole, and evened out. ANDREA bumped with an outer foe at the start, set the pace in the two path, came under a ride along the inside entering the far turn, dug in while tipping out to the three path in upper stretch, but was bothered by an outer pair passing the sixteenth pole, and yielded to that pair late. PARADISE CITY bumped with an inner foe at the start, was well back in the three path, driven in the four path around the far turn, swung out to the seven path at the top of the stretch, and improved. NOT TOO LATE tracked in the three path, was ridden in the two path around the far turn, floated out to the six path in upper stretch, but was one paced. VOLLEYBALL PRINCESS floated out to the five path around the first turn, rated inside up the backstretch, tipped out to the three path turning into the lane, but flattened. ZIP START was unprepared as the gates opened and broke slowly, chased in the two path but did not factor. SECRET FAITH stalked in the four path but yielded around the far turn. TOP had a slow start, trailed in the four path up the backstretch and never threatened. LUVUMORGAN rated inside but never menaced.
