1 1/8 MILES. (1483) CENTURY CASINO OAKS Purse \$100,000 (includes \$1,000 Starters Bonus)
A BLACK TYPE STAKE FOR THREE-YEAR-OLD FILLIES. A fee of \$100 required to nominate. A payment of \$1000 is required to pass the entry box and an additional \$900 is required to start. The purse will be divided \$60,000 to the owner of the winner, \$20,000 to the second place finisher, \$10,000 to the third place finisher, \$5,000 to the fourth place finisher and \$2,000 to the fifth place finisher. A payment of \$500 will be paid to all horses who start and finish 6th or worse. Starters to be named through the entry box by the closing time of entries. Preference will be determined by lifetime earnings as recorded by InCompass Solutions at time of entry. The field will be limited to 12 starters with 2 horses placed on the also-eligible list. The status of also-eligible horses will be determined at 10:00 AM MST on Saturday August 23rd, after pre-race veterinarian examinations. A trophy will be presented to the winning owner. WELCOMETO HOLLYWOOD tracked outside while three to four wide, moved up closer into striking range, fanned three wide leaving the backstretch, gained the advantage into the lane, and held. NO REJOYCE set the early pace from just off the rail, was in tight in the backstretch, then taken up, was roused into the stretch, dueled outside of DONTGIVEUP THE FIGHT late stretch and inched clear for place honours. DONTGIVEUP THE FIGHT prompted the early pace, angled in bumping into NO REJOYCE in the backstretch, was overtaken into the final turn, battled inside and was outfinished for second. KITTY HOUSE trailed early, swung five wide at the quarter pole, closed well and delivered a strong finish with a late surge. GEE I'M FOXY stalked the pacesetters, was in tight then bumped the rail, and launched an all out bid into the stretch. I'M IN CONTROL sat in striking distance while three wide, and lacked a closing response. UNVEIL THE GRACE stalked three wide leaving the opening turn, moved up four wide to challenge the lead, and left nothing in reserve late. STEWARDS INQUIRY- An inquiry was conducted by the Board of Stewards involving GEE I'M FOXY. After review of the film, it was determined that DONTGIVEUP THE FIGHT caused interference to NO REJOYCE, causing a chain reaction involving GEE I'M FOXY to bump the rail. DONTGIVEUP THE FIGHT was disqualified and placed fifth for interference.
