7 FURLONGS. (1.20²) ELLIS PARK JUVENILE S. Purse \$200,000 (includes \$100,000 KTDF – Kentucky TB Devt Fund) **FOR TWO YEAR OLDS.** Free nomination, \$500 to pass the entry box and \$500 additional to start. Supplementary nominations may be made at time of entry by payment of \$1,500 each (includes entry and starting fees). \$100,000 guaranteed plus an additional \$100,000 KTDF for KTDF eligible horses. After payment of 1% to all owners of horses finishing sixth through last, 62% of the remaining purse shall be paid to the owner of the winner, 20% to second, 10% to third, 5% to fourth and 3% to fifth. **Weights:** Colts and Geldings 122 lbs. Fillies 119 lbs. Non-winners of a race other than maiden or claiming, allowed 2 lbs.; a race other than claiming, 4 lbs. The maximum number of starters for the Ellis Park Juvenile will be limited to fourteen (14) starters. If more than 14 entries pass the entry box preference will be given to highweights with consideration to the sex allowance, then lifetime earnings. Any horse excluded from running because of the aforementioned preference shall be refunded the entry fee and supplementary nomination fee if applicable. Starters to be named through the entry box at the usual time of closing. A trophy will be presented to the winning owner. Nominations closed on July 26, 2025 with 16 nominations and 1 supplement.

COMFORT pressed the leader from the three path, vied reaching the three furlong pole, led passing the five sixteenths marker and drove clear of his stubborn inner rival. SPICE RUNNER set the pace in the two path as the eventual winner applied outer pressure into the turn, got headed by that one with five sixteenths to go, yet kept on well through the final furlong but was second best. PAPA KEN tracked along the inside, but proved no match for the top pair and held show. SHAKE AND RATTLE bobbled sharply at the start, trailed the shortfield along the inside, moved out of last two wide into the turn but failed to menace thereafter. LONGSTRIDER chased two wide, faded three wide into the turn and was done early.
