1¹/₁₆ MILES. (1.401) HAWKEYES H. Purse \$75,000 (includes\$37,500 IBF – Iowa Bred Fund) FOR FILLIES & MARES, THREE-YEAR-OLDS & UPWARD. (Iowa Registered & Foaled). No nomination fee. \$300 to pass the entry box and \$600 additional to start. \$75,000 guaranteed which will first be reduced so as to allow \$500 to be paid to each of the seventh through last place finishers with the remaining purse paid out as follows: 60% to the owner of the winner, 20% to second, 10% to third, 5% to fourth, 3% to fifth, 2% to sixth. SUPPLEMENTAL NOMINATIONS AT TIME OF ENTRY WITH A FEE OF \$1,300 TO ENTER AND START. Weights: Monday, July 28, 2025. Starters to be named through the entry box by the usual time of closing. Should this race not be divided and the entry number exceeds fourteen (14), high weights will be preferred, then highest 2024–2025 earnings. Different owners will have equal draw according to weights. The second parts of the same owner entries will have no consideration over a single interest. Failure to draw into the race cancels all fees. Closed Saturday, July 26, 2025 with 13 nominations.

KANOJO raced two wide around the first turn and rated off the clear top pair, edged closer on the top pair mid-way up the backstretch, advanced two wide and took over the lead at the quarter pole, hustled along three wide into the lane, responded gamely and pulled away. MISS PEACH raced three paths wide around the first turn and sat off the clear top pair in early stages, edged up closer mid-way up the backstretch, came under a ride three wide at the quarter pole, drifted four to five wide entering the head of the lane, angled back in a couple paths under firm right handed pressure and captured place. QUIET I'M NOT was allowed to settle around the first turn and rated off the quick early pace, picked up the tempo around the far turn, given cue two wide entering the head of the lane, ranged up behind the eventual winner, was no match for the pulling away winner but ran on with response and got denied late for place. SASSY AIN'T I was reserved racing in the back, hustled along three wide into the stretch and improved position without threatening. SAYUCAN sprinted off to the early lead with ELLL E racing in tandem along the outside, set swift early fractions, shook free to a brief lead near the half mile marker, got collared by the eventual winner at the quarter pole and had nothing left in the lane. ELLL E sped out to the lead with SAYUCAN racing in tandem, set quick fractions on top, could not keep pace past the half mile marker and dropped back.
