DUNN'S RIVER stalked the pace from three wide to the turn then moved up to engage the leader and dueled outside of ULTIMATE DESTINATN to the eighth pole, drew clear but was denied in the final jumps. ULTIMATE DESTINATN chased the leader to the turn then moved up to duel inside of DUNN'S RIVER to the eight pole and weakened. DYNAMIC VISION went to a clear lead to the three furlong marker before being eclipsed and tired. KERKYRA raced in the middle of the pack early then a dvanced going between horses near the three furlong marker, tipped out to four wide in upper stretch but flattened out. SOUND CITY was forwardly placed to the turn and saved ground around the turn but was not a threat. EMBERLIGHT raced near the back and moved up from two widearound the turn then tipped out to four wide in upper stretch to improve position. HER OWN SHADOW raced in the middle of the pack while saving ground butwas not a factor. SOUP TODAY trailed the field and was outrun. TWO TWENTY TWO raced in the middle of the pace from four wide, tipped out to five wide in upper stretch and gave way.
