RAGTIME broke slowly and took up at the start, laid off of the pace along the inside, altered course out to the five path to between horses at the three sixteenths pole, rallied to bid leaving the furlong grounds and drew clear under mild urging. STRONG STATE trailed in the three path, swung out to the six path entering the lane, rallied along with an inner rival leaving upper stretch, but failed to keep pace with that one leaving the furlong grounds and edged place at the sixteenth pole. DELIGHTFUL CLAIRE set the pace along the inside, dug in as an outer rival bid entering the lane, dueled neck and neck into midstretch, but got outkicked by a wider bidder leaving the furlong grounds and yielded place shortly after. MEGA MIL broke a step slow, pressed two wide, bid and sparked a duel entering the lane, battled into midstretch, but got outkicked leaving the furlong grounds and yielded between horses. STURGEON MOON laid off of the pace in the two path, checked slightly in the five path when an inner rival shifted across his lane at the three sixteenths pole and failed to factor. GERLIN'S EMPIRE tracked in the three path into and around the turn, chased in the four path in upper stretch, got outkicked by an outer pair at the three sixteenths pole and tired between horses. ECHO SOUND tracked along the inside, chased in the two path around the turn and faded.
