JUTL AND settled off the early pace, moved closer off the inside second turn, set down for the drive, proved no match for the winner, clearly second best. KID CHARLE MAGNE pressed the winner from the outside for over six furlongs, fell back from between the top two entering the stretch, had little more for that pair through the lane, while coming back in determined fashion to narrowly earn the show. TOUGH CRITIC void of early foot, continued back, came on the outside for the drive, staged a mild rally but was outfinished for the showspot. EMPIRE OF GLORY forwardly placed inside, continued within striking distance second turn, relented through the stretch. SMOLS raced back off the pace, failed to respond when called on in the drive.
