SILVER SLUGGER quickly claimed the early lead in the two path, held off foes through the turn, drifted out in the stretch but was able to hold for the win. NINJA WARRIOR settled close up four wide, moved up to stalk the pace three wide through the turn, unable to close the distance in the stretch. SHOWSTOPPER COPPER settled behind the pace three wide, split foes to press the pace through the turn, angled in to avoid drifting foe inside the final furlong. MY BUDDY B settled back to be the early trailer, passed tired foes three wide in the turn before angling back towards the inside of the stretch but came up empty. SUPER CHOW raced off the pace in the two path, trailed entering the stretch, passed tired rival. COMEDY TOWN stalked the pace from the inside early, slowly retreated through the turn. TRAINERS OBJECTION BY SHOWSTOPPER COPPER ON SILVER SLUGGER REGARDING THE STRETCH RESULTED IN NO CHANGE.
