VINCEY GIRL raced near the back through the turn then moved out to four wide in upper stretch to pass a tired one. CLARET BERET stalked the pace from three wide and made a mild bid to the top of the stretch and gave way. GALLOP D'HERMES was shuffled back early and chased the field from the inside and lacked a rally. ULTIMATE AUTHORITY was close up in the early then steadily faded.
