LENNILU away in good order, ceded the early lead and stalked the pace two wide to the turn, given her cue nearing the quarter marker, rallied to mid-stretch and took command into the final furlong, drew away into the final sixteenth and proved best in the late stages. THE PRINCESS BRO a step slow away from the start, recovered and tracked the quick early pace from the inside, was caught in traffic at the quarter marker and angled four wide for the stretch drive, rallied to the final sixteenth, could not reel in the winner in the late stages and bested the rest. MON STER broke sharply and showed good early speed, set a quick pace to the quarter marker, led to mid-stretch then was overtaken by the winner, yielded into the final sixteenth and just held for third. ITZA LOCK settled in the early going, roused four then five wide to upper stretch, mounted a late rally and just missed for third at the wire. SQUIRE tracked the solid early pace from outside of rivals, ran in pursuit three then four wide nearing the quarter marker then could not muster the needed late response. ZEVI'S ZONE settled off of the early pace, coaxed three wide to upper stretch, did not threaten in the late stages. TIMELESS VICTORY tracked the quick early pace from between rivals and two wide, chased the leaders into upper stretch, could not find a response into the final furlong and weakened. WIN N JUICE settled off of the early pace, coaxed two wide to the stretch, did not factor in the late stages. STREET PLAYER prominent away from the start, chased the quick early pace from the inside, was well placed into the turn, ran in pursuit to upper stretch then tired in the drive.
