1¹/₁₆ MILES. (1.41) HOOSIER HEARTLAND H. Purse \$100,000 (includes \$65,000 ITDF – Indiana TB Development Fund) FOR FILLIES AND MARES, THREE YEARS OLD AND OLDER REGISTERED INDIANA BREDS, SIRED BY REGISTERED INDIANA STALLIONS. No nomination fee, \$150 to pass the entry box and an additional \$100 to start with \$100,000 Guaranteed. Supplementary nominations may be made by the usual time of closing of entries for a fee \$625 which includes entry and starting fees. After paying 1% to owners of horses finishing sixth to last, the remaining purse will be divided 60% to the winner, 20% to second, 11% to third, 6% to fourth, and 3% to fifth. This race will be limited to twelve starters. Should more than twelve horses pass the entry box, preference will be given to high weights (scale of weights considered) then highest lifetime earnings will be used in determining the order of preference of horses assigned equal weights. Closed on Wednesday, August 27, 2025, with 24 Nominations.

IMAGINE THE MOON dueled outside of a rival and drew off late under a mild drive. CROSLEY dueled inside but couldn't match strides with the winner. ITZFOREVER stalked the pace inside, bid at the half-mile pole, raced in the three path in the stretch and had no late bid. TIZ BAYOU hopped at the start, raced inside and faded in the stretch. INNISFREE LASS raced in the four path, bid at the three-eighths pole and faltered. BRITTANYSGLDNFAITH saved ground, angled to the four path on the far turn and had no late bid. MARTZ ROSEY stalked the pace in the five path, moved to the three path near the half-mile pole and faded. JOLLY JUSTICE stalked the pace in the four path and gave way inside in the stretch. EVIL INTENTIONS was unrushed and passed tired rivals. CLASSIC KITTEN was not a factor. SOLRUN stalked the pace between rivals and faded on the far turn. BOOTLEGGER JUSTICE was through early.
