TROUBLESHOOTING bumped with Golden Afternoon at the break, raced two deep through the far turn, shifted out five wide near the quarter pole and edged up late under strong pressure. GOLDEN AFTERNOON broke to the outside, bumped with rival, stalked the top pair near the rail, shifted out four, vied between near the eighth pole and missed in a game effort. GOVERNOR SAM broke in, slight bump at the start, raced mid pack early on, split rivals two deep near the eighth pole and moved up in game finish. ANTISOCIAL broke to the outside, bumped, raced with the second flight, raced from the inside through the far turn and moved up late racing three deep. CHASING LIBERTY squeezed back at the break, raced four wide around the far turn and closed in mildly. DREAM ON raced near the back of the pack, two deep through the far turn, angled out near the eighth pole and needed more. OUT ON BAIL tracked the early leader two deep, led nearing the eighth pole and faltered in the final stages. BRIDLE A BUTTERFLY void of early speed, raced three to four wide around the far turn and lacked a rally. INNOVATOR raced mid pack in the early stages, raced four wide through the far turn and had no response. WARHEART stalked two to three wide and faded. MI BAGO showed good early foot to set the early pace and gave way in the drive. SPICED UP settled to race with the second flight, two deep near the eighth pole, lacked racing room and never threatened.
