ANGEL OF HOPE led under pressure inside, was taken up tiring at the top of the stretch. DOUBLE AIRO moved close up wide down the backstretch and gave way. MARILYN M vied along the rail for half mile and stopped. LITTLE COCOA BEAN prompted the pace initial quarter mile then drifted out stopping. A claim of foul by the trainer of the third finisher against the winner for interference at the top of the stretch was dismissed.
