

# TENTH RACE Parx

SEPTEMBER 19, 2025

1 MILE 70 YARDS. ( 1.38<sup>3</sup> ) STORM CAT S. Purse \$100,000 FOR REGISTERED PENNSYLVANIA BREDS, THREE YEARS OLD AND UPWARD. Early nomination fee of \$200 due by August 13. Late nomination fee of \$500 due by September 2. A supplemental nomination fee of \$1,500 may be made up to the closing of entries. \$300 to pass the entry box, \$500 additional to start, with \$100,000 guaranteed to be divided\*: 60% to the winner, 20% to second, 10% to third, 6% to fourth and 4% to fifth. \*All starters, excluding starters finishing first through fifth, shall be paid \$1,000 each and the remaining purse monies will then be divided as described above. Weights: Three-Year-Olds 123 lbs., Older, 126 lbs., winners of a sweepstakes in 2024-2025 to carry an additional 2 lbs., non-winners of \$30,000 since June 19, 2025 allowed 2 lbs. (Maiden, Claiming and Starter races not considered); of \$30,000 since March 19, 2025, 4 lbs. (Maiden, Claiming and Starter races not considered), Maidens 7 lbs. Starters to be named through the entry box by the usual time of closing. Should race overfill, horses with the highest total earnings in 2024-2025 preferred. A trophy will be presented to the winning owner.

NINETYPRCENTMADDIE eased back off the leader on the first turn, pursued, led in mid-stretch then held rival safe in a game effort. WILD VINE trailed well behind, advanced on the turn, split foes, loomed threat but could not get by the winner. DROPLINE set clear rapid fractions, was hooked into the stretch, resisted then tired slightly. HOUGHTON SHUFFLE settled off the pace between rivals then flattened out. MARKET MAVEN raced off the pace inside and gave way. KOHLER'S broke awkwardly, moved wide to contention then stopped. CAPO flashed speed initial quarter mile, stopped and lost contact with his field.
