Starters to pay \$1,200 additional with \$100,000 guaranteed. Supplementary nomination may be made at the time of entry for a fee of \$4,800, which qualifies to start. Starters to be named through the entry box by usual time of entry. Weights: Three-year-olds 119 lbs.; Older 124 lbs. Non-winners of \$50,000 once in 2025 allowed 2 lbs., Non Winners of \$25,000 once in 2025 allowed 4 lbs., Non winners of \$18,000 in 2025 allowed 6 lbs. (Maiden and claiming races not considered ). High Weights Preferred on the Scale, Highest Lifetime Earnings Will Be Used In Determining The Order Of Preference Of Horses with Equal Weights on the scale. Earnings will be determined according to statistics provided by Equibase. This race will be limited to fourteen starters. The guaranteed money to be divided 60% to the winner, 20% to second, 11% to third, 6% to fourth and 3% to fifth. A suitable award will be presented to the winning owner.

MIKEL W showed good early speed to set the pace, drew off turning for home then was in a hard drive but could not last in the end. RYVIT chased the early pace while two wide into the turn, was making a bid and gamely dug in but was no menace in late stretch. BIG EFFECT chased the early pace while three wide into the turn, made a bid but was no menace in late stretch. BREAKABLE CODE was unhurried early then rallied four wide in the stretch but was no threat. SECOND I D chased the early pace while inside into the turn, made a bid then faltered. STAGE LEFT was unhurried early then raced four wide in the stretch and was no threat. BLUE LIGHT was unhurried early then was five wide in the stretch and no factor.
