DENNARD saved ground around the first turn, settled in the middle of the pack on the inside for the run up the backstretch, began a bid from the rail coming around the far bend and drew off in the stretch. NORTHERN QUEST raced in the middle of the pack on the outside through the opening half mile, continued around the far turn still in the three path and chased on from there. VINNIEBOB saved ground around the first bend, dueled on the inside up the backstretch, continued to save ground around the second turn and gave way in the lane. DADDY WHAT IF was away from the gate slowly, raced in the two path early, trailed the field up the backstretch, navigated the far bend from the three path and made up some ground in the lane while never truly threatening. ATTILA THE DUN raced in the two path around the first turn, dueled on the outside up the backstretch, dropped back while racing in the two path around the far turn and faded in the stretch. MOVE OVER (GB) raced in the three path around the first turn, stalked the pace setter up the backstretch, fell passing the half mile pole and left the track in an equine ambulance. This race had a timing discrepancy or malfunction and was re-timed using video technology to arrive at the most accurate final time available.
