DAY TO DAY broke in at the start, chased just off the inside and then along the inside coming under encouragement at the three-eighths marker, spun two to three wide into upper stretch and tipped out to the five path straightened a way and weakened. SPA PROSPECTOR broke out at the start, chased four then three wide coming under encouragement midway on the turn, cornered three to four wide into upper stretch, tired.
