FIONN bumped with foes on both sides after the start then was squeezed back in tight guarters, settled inside to the two path. was roused on the final turn, moved to the three path late on that bend, swung out to the six path into the stretch then rallied on the outside, closed well to get the lead just inside the sixteenth-pole and prevailed under good handling. LAURELIN (IRE) dropped from the three path to the two path late on the first turn, was reserved off the pace, traveled around the second turn in the three path, continued with some cover on the backstretch, shifted from the two path to the four path late on the final turn, was roused in the five path into the stretch, gained to make a bid outside the furlong marker, led into the final sixteenth but was caught while clear for the place, DON'T JINX IT moved in while going to the front, showed the way on the inside, was asked while moving clear coming to the quarter-pole, came under a drive in upper stretch, led until just before the sixteenth-pole then was overtaken while just able to get the place. SCYTHIAN tugged eagerly on the bit while inside through the first turn, was rated while saving ground, came under urging near the quarter-pole then moved to the two path into the stretch, made a bid outside the furlong marker, battled into the final sixteenth and was outfinished then just missed the show. UNMERITED FAVOR dropped to the rear rounded the first turn in the two path, settled at the back while saving ground, was roused on the final turn, turned into upper stretch under a drive and lacked the needed kick then just missed the superfecta. NATIONAL ARCHIVE bumped with a foe after the start, tossed her head into the first turn, saved ground under reserve, was roused on the final turn, moved to the two path before the five-six teenths pole and lacked the needed response. HEREFORAGOODTIME tugged on the bit while in the two then three path through the first turn, stalked the pace on the outside, went around the second turn in the two path, continued outside of the leader down the backstretch. was given her cue in the two path on the far turn, dropped back coming to the quarter-pole and came up empty. EVERSHED (IRE) bumped with an opponent after the start, tucked from the three path to the two path late on the first turn, was rated off the pace. rounded the second turn in the two path, held a good position down the backstretch, was roused in the three path on the far turn, spuninto the stretchinthe four path and failed to respond.
