SWAMPY pressed the pace, saved ground around the final turn, got through on the rail, took the lead, was collared by LITEUPTHENITE down the stretch and proved second best. VARINISI lacked early speed, raced outside around the first turn, made a mild bid and proved no match for the top two. SARAH'S ROLLING pressed the early pace, forwardly placed throughout and weakened. WHISPER ME A SMILE sprinted to the front, drove clear, saved ground and faded. MO SKY raced near the back and showed little.
