GRAND SLAM SMILE raced up close to the outside of ISSA COURT up the backstretch, applied light pressure around the bend, came four wide into the lane, dug in to put head in front while making light contact with ISSA COURT midstretch and drove clear nearing the wire. ISSA COURT sprinted to the front and crossed over, led two wide into the turn, came under light pressure from GRAND SLAM SMILE and maintained the advantage two then three wide around the bend, resisted into the final furlong, lost command while brushing with GRAND SLAM SMILE midstretch and yielded late. NO CAP was hard to load behind the gate, stalked the speed from inside, was given her cue turning for home, flattened out in the final furlong but was able to hold third. HOT GIRL WALK unhurried in the early going on the inside, ridden along through the turn, moved out in upper stretch and earned a minor award. TINATURNER bumped with SNEAKER leaving the gate, tracked in range two wide into the turn, lost ground under coaxing around the bend, angled out into the lane and weakened. SEXY BLUE climbed early and dropped back to last, went two wide into the turn, moved out to the five path around the bend and could not make an impact. SNEAKER bumped with TINATURNER in the beginning, stalked three deep up the backstretch, spun five wide into the lane and weakened.
