TOASTMASTER tracked in the four path, received a right handed cue midway around the turn, angled out to the six path at the top of the lane, rallied past an inner pair just after the eighth pole, and went clear in the final sixteenth. COUNTRY PROMISES stalked in the three path, was roused passing the quarter, floated out to the five path at the top of the stretch, and ran on but could not keep up with the winner in the final furlong. BELLE BOTTOMS bumped with an outer foe at the start, set the pace in the three path, was roused in the two path passing the quarter, fought on into the final furlong, but yielded before the sixteenth. WONDER WORLD bumped with an inner foe at the start, was wellback in the five path, driven in the four path around the turn, but made no impact. HOLIDAYS ARMY BRAT rated inside, was coaxed along in the two path around the turn, cut the corner at the top of the lane, but weakened in the final furlong. FLASHY N chased in the two path but was no menace. MY KINDA PARTY prompted the pace in the two path early but retreated along the inside around the turn. NO CHANGES WERE MADE AFTER THE STEWARDS HELD AN INQUIRY LOOKING AT THE STTETCH RUN.
