6 FURLONGS. (1.08³) CHERYL S. WHITE MEMORIAL S. Purse \$200,000 **FOR FILLIES, THREE YEARS OLD.** Free nomination. \$1,000 to enter with \$200,000 Guaranteed. Supplemental nomination of \$4,000 will be accepted at time of entry which shall include all fees. The purse to be distributed: \$2,000 to all starters seventh through last. The remaining balance to be distributed: 60% to the winner; 20% to second; 10% to third; 5% to fourth; 3% to fifth; 2% to sixth. Weight: 124 lbs. Non-winners of an unrestricted Sweepstakes of \$60,000 or more in 2025 allowed 3 lbs.; \$60,000 twice in 2025, 5 lbs.; \$45,000 once in 2025, 7 lbs. (Maiden and Claiming races not considered in estimating allowances). First Preference to Graded Stakes winners in 2024-25; Second Preference to Graded Stakes placed horses and Stakes winners in 2024-25; Third Preference to highest total earnings in 2024-25. Starters to be named through the entry box Monday, November 17, 2025 by the usual time of closing. Trophies presented to the Winning Owner, Trainer and Jockey. (Formerly the Austintown Filly Sprint).

STILETTOS tracked in the two path, waited between rivals around the turn, split the leaders while being cued to bid at the top of the lane, and kicked away in the final furlong while being kept to task. VELVET DEVIL got bumped by an outer foe at the start, stalked in the four path, bid in the three path midway around the turn, ran on in the four path down the stretch to clearly be second best. TALIESIN trailed in the five path, was nudged along in the three path around the turn, and kept on from the four path down the lane for show. GERLIN'S EMPIRE bumped with an inner foe at the start, chased in the two path, was ridden in the four path around the turn, but flattened in the five path down the stretch. FLAT OUT TIME bumped with an outer foe at the start, dueled for the lead in the two path, tipped to the rail midway around the turn, was roused passing the quarter, fought on in upper stretch, but yielded in the final furlong. NOT TOO LATE steadied at the start, rated in the three path, was roused passing the quarter, fanned out to the six path at the top of the lane, but made no impact. TOP broke in and bumped an inner foe, raced off the pace in the four path, was driven around the turn, but made no closing bid. ANDREA vied for the lead along the rail but gave way around the turn. DOMINANT DIVA got bumped by an outer foe at the start, was up close in the three path but retreated.
