CONSEQUENT took a stalking position along the rail, drew closer following behind CASHED up the backstretch, angled out late on the far turn, chased determinedly into the final furlong, drew alongside the top pair with a sixteenth remaining and drove past CASH in the final fifty yards. CASHED cleared in the two path on the clubhouse turn, took pressure from NIMAH then raced on even terms up the backstretch, fought head to head around the far turn, drifted out slightly coming into the lane, brushed with NIMAH in upper stretch, took light contact from that rival inside the eighth pole, carried a short lead over outer pair with a sixteenth remaining but could not fend off CONSEQUENT late. NIMAH away quickly from outside, forwardly placed three wide around the first turn, challenged CASHED on the backstretch, dueled around the far turn, brushed with that rival in upper stretch, drifted in and brushed with CASHED again past the eighth pole and yielded to the top pair in deep stretch. COSMIC HEAT lost her path leaving the gate, trailed in the two path to the lane, moved out and had little left for the drive. JEWLZ tracked four then three wide early, stayed off the rail to the second bend, eased further out and came five wide into the stretch and faded down the lane. THERE WAS AN INQUIRY INVOLVING CASHED AND NIMAH IN THE STRETCH. FOLLOWING A REVIEW, THE STEWARDS ACKNOWLEDGED THERE WAS SLIGHT CONTACT BETWEEN THOSE RIVALS BUT THE INCIDENT DID NOT WARRANT A DISQUALIFICATION.
