ULTIMATE DESTINATN showed the way in the two path, drew clear entering the lane and held sway. JAC'S DOE MAKER was bumped by an outer rival leaving the gate, raced close up along the inside, checked back into the turn, chased around the bend, stayed on inside of rivals while hanging on his left lead and re-edged place late. SOUP TODAY tracked from the three to four path, tipped out to the five path in midstretch, stayed on while hanging on his left lead and reached show at the wire. SOUND CITY pressed the eventual winner from the three path and between horses around the turn, yielded to that one entering the lane, kept on between foes in the final furlong and missed show to an outer bidder at the wire. BOSABROTHER bobbled subtly at the start, bumped with an inner rival early on, stalked from the four path, vied for place in pursuit of the clear leader into the final furlong but yielded between rivals late. SAMMY'S HALO raced off of the pace near the two path, then failed to challenge while hanging on his left lead. COWGIRL SLUVME tracked from the five path and lacked a bid. DREAM BOY leaned inwardly and bumped a foe at the start, lacked speed in the four path and failed to factor. DUNN'S RIVER got pinched between horses and steadied back early on, raced off of the pace in the six path and tired. GLORY REIGNS was away awkwardly and off slow, trailed along the inside and got outrun. VALIANT STRIKE bumped with an inner foe early on, raced off of the pace in the three path and tired. THE RIDER OF DUNN'S RIVER CLAIMED FOUL AGAINST VALIANT STRIKE AND COWGIRLSLUVME ALLENGING INTERFERENCE IN THE EARLY STAGES, BUTTHE OBJECTION WASDISALLOWED BY THE STEWARDS.
