EXPRESS KID showed good early speed from the gate to set the pace, was well handled on the backstretch then drew off turning for home and was confidently ridden to the wire. ARCTIC BEAST was settled while inside on the run down the backstretch, saved ground on the far turn then made a strong bid on the far turn to mid stretch but was no match for the winner in late stretch. ROYALAMERICAN was bumped on the first turn then allowed to settled inside on the backstretch, saved ground on the far turn then made a bid and finished well. WESTERN MAN was allowed to settled while three wide on the backstretch, rallied four wide on the far turn making a bid then came up empty in late stretch. WAY BEYOND was allowed to settled while two wide on the backstretch, made a bid three wide in the stretch but was no menace. BIG APPLE PATRICK was allowed to settled then raced four wide on the far turn making a bid then flattened out in the drive. ESSENTIAL TIME was unhurried early then rallied and swung out to be six wide in upper stretch and made a mild rally. JETS RIO showed good early speed from the gate then chased the pace while two wide, was used up then gave way going into the far turn. TIME FOR MUSIC was inside on the run down the backstretch then failed to menace. SUPREME GOOD (IRE) was unhurried early while inside and was no threat. SPICE RUNNER was pin balled around going into the first turn then chased the early pace while three wide, was used up then gave way on the far turn.
