ANEGADA settled off of the pace in the two path, shifted out to the six path while picking up stride along with an outer FINAL GAMBIT entering the lane, rallied to bid with that one at the sixteenth pole, battled neck-and-neck through the closing stages and narrowly prevailed. FINAL GAMBIT was allowed to settle at the rear in the two path, took the far turn in the four path before fanning out to the seven path entering the lane, rallied along with an inner ANEGADA to bid at the sixteenth pole, sparred with that one late but just missed. ENERGIZE laid off of the pace in the three path, progressed in the four path rounding the far turn, bid at the quarter pole, forged an advantage in upper stretch, but got caught by an outer pair at the sixteenth pole then held show. URBAN PLANNER stalked in the two path, bid along with an outer rival reaching the quarter pole, got outkicked in upper stretch, kept on mildly and held fourth. CALIFORNIA BURRITO tracked along the inside, awaited racing room rounding the far turn, shifted to the two path nearing the lane, moved out to the four to five path and between horses entering upper stretch but lacked a bid. FOUNTAIN RUN brushed with an inner rival at the start, sent clear around the first turn, met a pair of outer challenges at the quarter pole and weakened. NATIONAL LAW brushed with an outer rival at the start, tracked in the three path, got outmoved by an outer rival turning for home then faded.
