CHAMPLIN stumbled then bumped with rival at the start, hustled to vie for the lead into the turn while moving up then made a late run with strong strides late to drive past the leader for the win. OLD HOMESTEAD broke outward leaving the gate then rushed up and dueled for the lead before edging clear going into the turn and was caught late but was a clear second. DEVIL'S TOWER raced near the back to the turn then made a mild bid and gave a late run to be up for the show. AMERICAN KNOW HOW bumped with rivals leaving the gate then tracked leaders down the backstretch, moved up from two wide on the turn but was outkicked late. THE DONEGAL CLAN bumped with rivals and was shuffled back at the start, trailed the field to the top of the stretch but ran into traffic and had to move between horses near the sixteenth pole for a late run but was too late. CHAD'S FLASHY WAYS raced near the back from four wide to the turn then made a mild bid but was empty in the stretch. COUNTRY HIT was forwardly placed from three wide to the turn then made a mild bid around the turn but lacked the late response needed. GO CAPTAIN broke out and bumped with rival, then was hustled along to duel for the lead to the three furlong marker before giving way. EMPIRE OF GOLD was away sharply then faded quickly and never contended.
