1 MILE. (Turf) (1.31²) SUNSHINE FILLY AND MARE TURF S. Purse \$75,000 FLORIDA-BRED FILLIES AND MARES, FOUR YEARS OLD AND UPWARD. Free nomination by Sunday, December 28. \$25 to enter. A supplemental nomination fee of \$100 may be made prior to closing time of entries. After payment of 1% to all owners of horses finishing sixth through last, 62% of the remaining purse shall be paid to the owner of the winner, 20% to second, 10% to third, 5% to fourth, and 3% to fifth. Weight: 125 lbs. Non-winners of a graded stakes at a mile or over in 2024-25 allowed 3 lbs.; a stakes race at a mile or over since July 1 or three races other than maiden, claiming or starter, 5 lbs.; stakes placed in 2024-25 or two races other than maiden, claiming, or starter, 7 lbs. Starters to be named by usual time of closing. All fees shall be paid prior to the start of the race. Preference will be given to stakes winners, then by highest career earnings. Trophy to the winning owner. In the event this race is taken off the turf, it will be run at a distance of One Mile and Seventy Yards on Tapeta course. (If deemed inadvisable to run this race over the turf course, it will be run on the Tapeta Course at One Mile and Seventy Yards) (Rail at 31 feet).

SOUPER ZONDA raced closest to the clear pacesetter in the two path, steadily gained around the far turn and through the lane and was up in deep stretch. RUGELACH set a clear pace along the rail, held clear past the eighth pole, drifted out a bit late and gave way grudgingly. ASHIMA raced well back three wide around both turns, angled five wide in upper stretch and finished willingly to gain the show late. SOUPER WILLIAW was strung out four wide around the first turn, remained off the pace while down to two wide around the far turn, rallied between foes and was outkicked for the show. SPIRITED BOSS raced in range three wide and lacked the needed rally. LUZ DE LA LUNA chased the pace inside and lacked a closing bid. MISS MARY NELL chased the pace two wide between foes around the far turn, dropped back inside around the far turn and never threatened. SAPPHIRE GIRL was outrun inside. LADY CHA CHA trailed inside.
