AUGUSTA MELODY pressed the pace on the outside up the backstretch, came around the turn in the three path, dueled in upper stretch and edged up for the win. NEIMAN dueled on the inside early, saved ground around the turn, dug in gamely in upper stretch and gave way late. RYVIT stalked the pace setter between horses up the backstretch, saved ground around the turn and gained ground late. MISSION BEACH tracked the leaders on the inside up the backstretch, dropped back while racing in the four and five path around the bend and chased on to the wire. FINAL STORM chased the leaders between horses through the opening quarter, navigated the turn from the three path and weakened in the lane. DEAN'S LIST stalked the leader on the outside up the backstretch, came around the turn in the four path and faded in the stretch. RUGGS dueled between horses up the backstretch, raced in the two path around the bend and tired in the lane.
