SPEED MERCHANT tracked the leader on the outside up the backstretch, navigated the turn from the three path and kicked clear in the lane. CASH WATERFALL stalked the pace setter between horses up the backstretch, continued around the turn in the two path and gained ground late. BUY LOCAL dueled between horses through the opening stages, saved ground around the bend and chased on to the wire. READS ARTFUL RUN raced off the pace on the inside up the backstretch, came around the turn in the four path and improved position in the lane. RISK CAPITAL dueled on the inside early, dropped back while racing in the three path around the turn and continued to fade in the stretch. FORTSUMNER dueled on the outside up the backstretch, continued to battle from the two path around the bend and tired from there. COWBOY CAMPFIRE chased the leader on the outside up the backstretch, navigated the turn from the two path and was empty in the lane. COUNTRY CLUB SPORT stalked the leaders on the outside up the backstretch, continued around the turn in the four path and tired in the stretch.
