WHISPER ME A SMILE rushed to a clear lead down the backstretch before being headed going into the final turn, fended off the challenge then drew clear to prove best. MIDNIGHT PASSION was fractious in the gate, stalked the pace from three wide, moved up to engage the leader going into the final turn but couldn't catch and was clearly second best. LITEUPHENITE settled in the middle of the pack while saving ground, made a rail bid on the final turn but was no match for the top two and was a clear third. VARINISI was allowed to settle near the back from three wide and made a mild three wide bid on the final turn but had no impact. MO PUMPKIN trailed the field to the top of the stretch and passed a tired one. APPEAL prompted the pace from two wide to the three furlong marker and gave way.
