

**1 MILE. ( Turf ) ( 1.312 ) HONEY FOX S. PRESENTED BY MYRACEHORSE Grade III Purse \$175,000 ( includes \$25,000 FBIF – Florida Bred Incentive Fund ) FILLIES AND MARES, FOUR YEARS OLD AND UPWARD. Free nomination by Sunday, February 15. \$1,375 to enter. A supplemental nomination fee of \$150 may be made prior to closing time of entries. After payment of 1% to all owners of horses finishing sixth through last, 62% of the remaining purse shall be paid to the owner of the winner, 20% to second, 10% to third, 5% to fourth, and 3% to fifth. (\$25,000 to the owners of a registered Florida-bred divided \$17,500 to the winner, \$5,000 to second, \$2,500 to third). Weight: 124 lbs. Non-winners of a graded stakes on turf since August 1 allowed 2 lbs.; a stakes race on turf since May 1 or three races other than maiden, claiming, starter or State-Bred allowance, 4 lbs. Starters to be named by usual time of closing. All fees shall be paid prior to the start of the race. Preference will be given to graded stakes winners in 2025–26, graded stakes placed in 2025–26 then by highest career earnings. In the event this race is taken off of the turf, it may be subject to downgrading upon review by the Graded Stakes Committee. (If deemed inadvisable to run this race over the turf course, it will be run on the Tapeta Course at One Mile and Seventy Yards) (Rail at 66 feet).**

LUSH LIPS (GB) settled off the pace two wide, angled four wide near the quarter pole, kicked in outside and was up late. CLASSIC Q moved two wide to the lead around the first turn, drew clear down the backstretch, extended the lead around the far turn, led to deep stretch and was caught late. SILVER MOONLIGHT led at the rail early, deferred to CLASSIC Q midway around the first turn, stalked inside down the backstretch and around the far turn, tipped two wide in upper stretch, steadily gained on that foe through the lane but was outkicked between the top two late. CREVALLE D'ORO saved ground off the pace and rallied belatedly inside of foes. MOVIN' ON UP raced in range three wide and lacked the needed rally. PUBLIC DEFENDER was outrun inside. SOUPERZONDA rated back off the pace, became rank and was checked repeatedly around the first turn and down the backstretch, was let go for a middle move midway down the backstretch, prompted two wide into the far turn and came up empty not long after.
