Purse \$135,000 FOR FOUR YEAR OLDS AND UPWARD WHICH HAVE NEVER WON A SWEEPSTAKES OTHER THAN STATE BRED OR RESTRICTED.** No nomination fee. \$500 to pass the entry box and \$500 additional to start. Supplementary nominations may be made by the closing time of entries for a fee of \$1,500 which qualifies to start. \$135,000 Guaranteed. After paying 2.5% of original purse to the owners of horses finishing 6th through last, 60% of the remaining purse will be paid to the owner of the winner, 20% to second, 10% to third, 6% to fourth and 4% to fifth. **WEIGHTS:** 124 lbs. Non-winners of \$75,000 in 2025 allowed 3 lbs.; \$60,000 in 2025 allowed 5 lbs.; \$50,000 in 2025 allowed 7 lbs. (Maiden and Claiming races not considered in allowances). In Allowance Stakes starting preference will be given to horses that have accumulated the highest earnings. Starters to be named through the entry box by the usual time of closing. The Owner of the winner to receive a trophy. Closed Tuesday, January 20, 2026 with 33 nominations.

MACKMAN prompted the pace in the three path, was roused between foes in the two path midway around the far turn, bid passing the quarter, dueled with rivals on both sides to the wire, and inched a head in the final strides. SUPER CRUISE showed the way in the two path up the backstretch, came under pressure along the inside midway around the far turn, dug in gamely while trying to fend off an outer pair from the two path to the wire, but was edged out in the closing stages. FIRST DIVISION chased in the three path, waited behind a wall of rivals around the far turn, angled out to the five path in upper stretch, ran on to make it close late, but lost a photo to end up with show. GUN PARTY bumped with an inner foe at the start, tracked inside up the backstretch, was cued from the rail midway around the far turn, cut the corner at the top of the stretch, but flattened in the final furlong. SIR GREYLIND bumped with an outer foe at the start, rated in the four path up the backstretch, was coaxed along around the far turn, floated out to the seven path in upper stretch, but faded. CREATIVE MINISTER trailed in the two path, was pushed along around the far turn, but made no closing bid. ENERGIZE stalked in the four path, was driven in the three path around the far turn, floated out to the six path at the top of the lane, and weakened.
