MOJICA set contested early pace inside, shook free of PROBATE into upper stretch, drew off in hand to deep stretch and won as much the best. MARKING CANYON crowded start and off a bit slowly, recovered and tracked the early pace between foes, angled three wide nearing the top of the lane, was no match for the winner in the late stages but held well for the place. HOLY HANK tracked early pace outside, chased four wide to upper stretch, outkicked for second and clear of the rest for third. ANTONIOS MARK tracked inside, saved ground along the turn, chased inside to upper stretch, needed more late. DAVE'S ENCHANTMENT rated early, tracked three to four wide turn, no late response. AR YA WEEGEE unhurried early, widest along turn and into upper stretch, no threat late. PROBATE prominent early, contested pace outside to quarter pole, faded stretch. THE JOCKEY OF HOLY HANK LODGED AN OBJECTION AGAINST THE JOCKEY OF MARKING CANYON, CLAIMING INTERFERENCE ON THE TURN. THE STEWARDS DISALLOWED THAT OBJECTION AND RULED THERE WOULD BE NO CHANGE.
