NEIMAN stalked three wide to the turn, lost position nearing the quarter marker, swung widest to upper stretch and re-rallied four wide into the lane, was gaining late and held safely for second. RYVIT contested pace between two wide into the turn, met the bid of CLOVISCONNECTION into upper stretch, yielded late and held for third. KATONAH bothered start, settled inside, angled out stretch, no final kick. AUGUSTA MELODY showed speed, dueled pace inside, gave way stretch.
