BUY LOCAL attended pace between two wide to half, shook free upper, drew clear into the final furlong and ridden out in the late stages. SPEED MERCHANT lunged start and off a bit slowly then caught in traffic heading to the first turn, stalked the pace three wide along the backstretch, vied for the lead nearing the top of the lane, could not match strides with the winner into the stretch and held for second. CASH WATERFALL tracked outside, well placed while four wide nearing the half-mile, chased to upper stretch then angled in nearing the furlong marker, bid to the final sixteenth, was outkicked for place and was well clear of the rest for the show honors. M G ROJO LOCO off bit slow, unhurried to half, coaxed two wide to upper stretch, by tired foes late. APREMONT settled to half, coaxed three wide upper, no threat stretch. READS ARTFUL RUN took back, saved ground to stretch, no factor. VANISHING MONEY showed speed, set prompted pace to far turn, faded stretch. RISK CAPITAL keen early, chased pace to the quarter marker, lacked the needed response into the stretch, jumped tracks in the final sixteenth and unseated the jockey, was caught following the race and walked off. THE STEWARDS CONDUCTED AN INQUIRY INTO THE INCIDENT INVOLVING RISK CAPITAL NEARING THE FINISH LINE AND RULED NO ACTION WOULD BE TAKEN.
