With \$25,000-added of which 60% of the total monies to the owner of the winner; 20% to second; 12% to third; 5% to fourth and 3% to fifth. Weights: Three-Year-Olds, 121 lbs.; Older, 125 lbs. Non-winners of \$9,000 twice in 2025-2026 allowed 3 lbs., Of \$9,000 in 2025-2026, 5 lbs. Maiden, Claiming and Starter races not considered in allowances. High Weights preferred on the scale. Total earnings in 2025-2026 will be used in determining the order of preference of horses assigned equal weights. Closed Saturday, March 7 with eleven nominations.**

TELLITTOTHEJUDGE stalked the pace, raced four wide into the upper stretch and prevailed late under all out pressure. LADY MAZATLAN lunged at the break, settled back along the inside, move up between three wide near the eighth pole and finished gamely to the wire. TAPITURE'S LADY dropped back early, made a three to four wide bid through the lane and closed in too late. GIO FACTOR tracked the early leader two deep and weakened the final eighth of a mile. FAST N BREEZY set all the pace and gave way. A DETERMINEDMOM raced two to three wide and had no response. GOLDIES CLAIM was off slowly, trailed early on, saved ground and never threatened. This race was originally hand timed and was re-timed using video technology to arrive at the most accurate times.
