5 FURLONGS. (Turf) (.533) SILKS RUN S. Purse \$125,000 (includes \$25,000 FBIF – Florida Bred Incentive Fund) **FOUR YEAR OLDS AND UPWARD.** Free nomination by Sunday, February 22. \$875 to enter. A supplemental nomination fee of \$200 may be made prior to closing time of entries. After payment of 1% to all owners of horses finishing sixth through last, 62% of the remaining purse shall be paid to the owner of the winner, 20% to second, 10% to third, 5% to fourth, and 3% to fifth. *(\$25,000 to the owners of a registered Florida-bred divided \$17,500 to the winner, \$5,000 to second, \$2,500 to third). Weight: 124 lbs. Non-winners of a graded stakes since September 1 allowed 2 lbs.; a stakes race since then or three races other than maiden, claiming, starter or state-bred allowance, 4 lbs. Starters to be named by usual time of closing. All fees shall be paid prior to the start of the race. Preference will be given to stakes winners 2025-26, stakes-placed 2025-26, non-restricted stakes winners 2025-26, then by highest earnings in 2025-26. Trophy to the winning owner. (If deemed inadvisable to run this race over the turf course, it will be run on the Tapeta Course at Five Furlongs) (Rail at 73 feet).

REZASROLEX raced off the duel in the clear in the three path, bid in midstretch but was outkicked. EAMONN raced off the pace two wide, tipped further out in upper stretch and rallied to gain the show in the final strides. SOSUA SUMMER settled off the pace three wide, angled widest in upper stretch and was outfinished for the show. CLASSIC OF COURSE trailed inside and rallied belatedly. COPPOLA dueled two wide, drifted out a bit in upper stretch, vied to midstretch and weakened. SOUPER QUEST dueled at the rail and tired in the final furlong.
