**HOLY MISS** broke in at the start, settled to the backstretch and coaxed widest to the half-mile point, roused four wide to the quarter pole, sustained her bid into the final furlong and dueled **MARKA** to the final sixteenth, took a narrow lead in deep stretch and held late to prevail. **MARKA** crowded and bothered by an outer rival at the start, was a bit keen in the early going and tracked the pace four wide to the backstretch, chased three wide into the far turn then vied for the lead to upper stretch, took command into the final furlong, met the bid of **HOLY MISS** and dueled that foe to the final sixteenth, was gamely bested in the final strides and held clearly for second. **UNWOUND** forwardly placed in the early running, stalked the decent pace three deep into the backstretch run, chased into the far turn then was caught a bit in tight nearing the quarter pole, fought on into the stretch, was outkicked by the top pair in the late stages and was a clear third. **AWESOME GLORY** was crowded at the start by an inner rival, showed speed and assumed early command, set a decent pace to the half-mile, met oncoming bids into the far turn and led to upper stretch, was overtaken at the furlong pole and faded late. **I AM PAULA REVERE** broke a step slowly, unhurried while saving ground to the backstretch, navigated traffic to the far turn, angled widest to upper stretch and could not muster the needed late response. **COUNTRY CLUB CRUSH** broke out start, was keen to the first turn, went up and prompted the decent pace two wide into the backstretch, pressed to the far turn then dropped back nearing the quarter marker, stopped into upper stretch, was eased through the lane and walked off. **THE TRAINER OF MARKA LODGED AN OBJECTION AGAINST HOLY MISS, CLAIMING INTERFERENCE AT THE START. THE STEWARDS DISALLOWED THAT OBJECTION AND RULED THERE WOULD BE NO CHANGE.**
