6 FURLONGS. (107²) ROXELANA S. PRESENTED BY LG&E KU Purse \$200,000 (includes \$50,000 KTDF – Kentucky TB Devt Fund) FOR FILLIES AND MARES FOUR YEARS OLD AND UPWARD. By subscription of \$100 each, which should accompany the nomination or by Supplementary Nomination of \$750 at time of entry. \$750 to pass the entry box; \$750 additional to start, with \$150,000 guaranteed plus an additional \$50,000 KTDF for KTDF eligible horses. After payment of 1% to all owners of horses finishing sixth through last, 62% of the remaining purse shall be paid to the owner of the winner, 20% to second, 10% to third, 5% to fourth and 3% to fifth. Weight, 123 lbs. Non-winners of a grade I since October 1, allowed 3 lbs.; a graded sweepstakes in 2026, 5 lbs. The field will be limited to 14. If more than 14 entries pass the entry box preference will be given to graded stakes winners (in order I–II–III), then highest 2025–2026 earnings. Any horse excluded from running because of the aforementioned preference shall be refunded the entry fee and supplementary nomination fee if applicable. Starters to be named through the entry box at the usual time of closing. All supplementary nominations will be required to pay entry and starting fees if they participate. Trophy to the winning owner. Closed Wednesday, April 8, 2026 with 34 nominations.

ONE MAGIC PHILLY brushed an outer foe at the start, stalked along the inside, bid inside of the leader entering the lane, drew clear shortly after then held sway. JERSEY PEARL was brushed by an inner foe at the start, set the pace in the two path, got headed by an inner bidder entering upper stretch, kept on to sustain pursuit of that one and held place. ASTERNIA bumped with an inner foe leaving the gate, stalked from the three path, stayed on to sustain pursuit through the lane but needed more for place. ZEITLOS bumped with an outer foe at the start, saved ground off of the pace, but only offered a mild kick and lacked a bid. MINK'S PALACE chased in the four path then gave way. VINCEY GIRL was bumped between horses and bobbed at the start, trailed in the five path and failed to factor. A STEWARDS' INQUIRY REVIEWING THE START RESULTED IN NO CHANGE TO THE ORIGINAL ORDER OF FINISH.
