**MASKEDANDMUMMED** fractious in the gate pre-start, chased three wide around the turn, clean path four deep leaving the furlong marker, forged clear under strong handling. **TRUTH AND JUSTICE** fractious in the gate pre-start, chased between runners nearing the quarter pole, bid five wide upper, rallied very late for the place award. **EDY'S FLAME** chased inside off the pace leaving the quarter pole, angled out three wide for the stretch run, chased on well late. **GOD'S PRIDE** lacked speed out of the chute, circled seven wide upper, improved placing through the wire. **CAPPUCCINO CRUNCH** broke alertly, chased two wide into the turn, sent clear approaching the furlong marker, flattened out inside rivals through the final stages. **KARINA ANNA** broke a step slow, chased inside around the turn, lacked room in deep stretch, came up empty. **MY GIRL BRIDGIT** pressed between runners into the turn, six deep and still between leaving the furlong marker, weakened through the stretch. **PRIORITY ONE** fractious in the gate pre-start, broke sharp at the bell, set the pace inside into the turn, collared in upper stretch, wilted through the lane.
