1¹/₁₆ MILES. (1.43) BOSSELMAN PUMP AND PANTRY/GUS FONNER S. Purse \$100,000 FOR THREE YEAR OLDS AND UPWARD. PURSE \$100,000-added (\$50,000-added plus \$50,000 from Bosselman Enterprises). No nomination fee. \$500 to pass the entry box and an additional \$500 to start. Supplemental nominations at the time of entry with a fee of \$1,500 to enter and start. With \$100,000-added of which 60% of the total monies to the owner of the winner; 20% to second; 12% to third; 5% to fourth and 3% to fifth. Weights: Three-Year-Olds, 121 lbs.; Older, 125 lbs. Non-winners of \$30,000 at a mile or over in 2025-26 allowed 2 lbs.; \$21,000 at a mile or over in 2025-26 4 lbs., \$10,000 at a mile or over in 2025-26, 6 lbs. (Maiden, Claiming and Starter races not considered in weight allowances). High Weights preferred, on the scale. Total earnings in 2025-2026 will be used in determining the order of preference of horses assigned equal weights. Horses not drawing a starting position in the gate will receive a refund of the entry fee. Closed Wednesday, April 8 with twenty seven nominations.

CORNISHMAN saved ground early, moved three wide in the far turn, rallied strongly into the lane and was just up from a fast closing ZATARA late. ZATARA dropped back early, launched his rally three wide on the far turn, came five wide into the lane and closed from widest but could not reach the winner. KOMOREBINO OMOIDE (JPN) tracked the pace outside a rival to bid going up the backstretch, moved clear in the far turn then wore down through the lane. THUNDERS ROCKNROLL made the pace on a short lead about the three to four path and came up empty nearing the lane. SPRINT OUT PASS stalked the pace in good position four wide but weakened through the far turn. SPENARD saved ground and failed to mount a rally. MALIBU S S failed to mount a bid four wide. FORCED RANKING was always back. This race was originally hand-timed and reviewed using video technology to arrive at the most accurate times available.
