MOHAVEN sprinted clear and showed the way up the backstretch, maintained a comfortable lead along the rail around the bend, responded to left handed urging in the lane and drew off. DONTTELLMEWHATTODO was closest in pursuit of MOHAVEN in the early going, chased inside ANOTHER ZERO through the turn and outkicked that rival for the place honors. ANOTHER ZERO followed in range from off the rail, chased outside DONTTELLMEWHATTODO around the bend, chased within striking distance to the eighth pole and flattened in the late stages. LINO'S ANGEL allowed to settle outside a rival, chased in the two path on the turn and failed to rally when called upon. TAPATIA MIA stalked outside a rival then three deep early, navigated the turn in the three path and weakened in the drive. CEE DREW sat off the pace on the inside, asked along the fence around the turn and failed to menace. TOO SASSY chased from off the pace out wide, went four wide into the turn, angled in and came two wide into the lane, steered back out near the eighth pole and had little left for the final furlong. CECILIA STREET was fractious in the gate, broke a step slow, trailed up the backstretch, took the turn three then two wide and never got involved.
