MARK MY WORDS pressed in the three path, took command while being roused midway around the turn, floated out to the five path in upper stretch, and drew clear. COWGIRLS LUV ME bumped with an inner foe at the start, was well back in the four path, coaxed along around the turn, floated out to the five path in upper stretch, and kept on while on the left lead to be second best. SHELTOWEES ROCKET tracked in the three path, was cued passing the three-eighths pole, angled out to the six path at the top of the lane, and stayed on to get up for show. WATER INTO WINE set the pace in the two path, lost the lead while driven between foes midway around the turn, then had to steady at the top of the stretch, and faded. GLOBAL EVENT chased in the three path, was driven around the turn, fanned out to the seven path at the top of the stretch, and passed tired inner foes. SOUP TODAY trailed in the two path, was driven around the turn, but made no impact. SUN OF WAR stalked in the five path, was ridden in the four path around the turn, but retreated. RUN BOBBY RUN bumped with an outer foe at the start, raced in range along the rail, bid for the lead passing the three-eighths pole, floated out to the three path entering the stretch, but yielded between foes in the final furlong.
