MARK MY WORDS quickly claimed a ground saving lead under pressure from WATER INTO WINE, pulled away from the rest of the field whilst dueling that on rounding the far turn, floated out during the stretch run to bump that foe repeatedly, kept a head in front at the wire. WATER INTO WINE saved ground to press the pace setter, pulled away from the rest of the field rounding the far turn while in contest with MARK MY WORDS, continued dueling that foe in the stretch and was bumped out repeatedly to be held off. GLOBAL EVENT shadowed the lead between runners, came under strong encouragement in the far turn but was unable to keep up with the dueling leaders, held for the show award. JOLLY MON settled off the pace, swung to the far outside at the top of the stretch, showed a driving effort to improve position. RUN BOBBY RUN found a forward position five wide in the early stages, flattened out late. DREAM BOY trailed distantly for most, passed tiring rivals. SHEL TOWEES ROCKET tracked the pace four wide between runners, lacked a bid, retreated. COWGIRLS LUVME settled off the pace, never switched leads. MY TROOPER chased the pace from the inside, weakened in the stretch. STEWARDS INQUIRY WAS RAISED REGARDING INTERFERENCE IN THE STRETCH RUN RESULTED IN THE DISQUALIFICATION OF MARK MY WORDS FROM FIRST AND PLACED SECOND BEHIND WATER INTO WINE.
